Under New Business, there was discussion about doing something for the past president, Bill Miles, perhaps at our conference... Under Old Business, Sid Turner will again head the VCI Advisory Committee in planning our annual conference... Karenne Wood, Executive Director of the Virginia Indian Heritage Program, announced the availability of the 3<sup>rd</sup> edition of the Virginia Indian Heritage Trail... A letter from Walt Brown of the Cheroenhaka Nottoways was read and VCI is still working on a response... Under announcements, the next VCI meeting will be held November 18, 6:30 p.m. in the General Assembly Building... Karenne Wood will speak on October 21 at Virginia Tech, 7 p.m. ... The George Mason University Veterans Powwow will be held November 9, 1-10 p.m. The meeting was adjourned at 7:30 p.m.

Oct 21 – Mitchell Bush/Verde Halley took their guest, Alfred Casanova, for a tour of Indian Pines. #### American Indian Society of Washington, DC Minutes – November 4, 2009 The Church of St. Clement - Episcopal, Alexandria, Virginia

President Michael Nephew called the meeting to order at 8:09 pm with the following members present: Mitchell Bush, Karen Collins, Myra Dunwoody, Tia Gibbs/Steve/Nick Hill, Eloise Giordano, Verde Halley, Eve Hill, Jay Hill, Cathi Hill, Keith Hunsucker, Pete Neconie, Michael Nephew, Rose Powhatan/Michael Auld, Pauline Prater, Manuel Rodriguez/Karen Mallicoat-Rodriguez, Mary Sunbeam, Marietta Van Pelt/Dakotah Adams, Sam Wakefield, John Wigle, Joyce Wakefield, Mill Butler, Darlene Farmer and Tony Richardson. Steve Hill offered the opening prayer.

The minutes of the October 7, 2009 meeting were read by Cathi Hill and approved as read. The treasurer's report was given by Mary Sunbeam. Mary reported that she is now current from July to September 2009 on Quickbooks. Mary offered to teach anyone who want to learn how to use the Quickbooks accounting system. Mary also extended gratitude to all those that have helped her in getting the accounts up to date. A suggestion was made to make the AIS Savings account in to the Scholarship account. After some discussion about the amount of money in the account Mary Sunbeam made a motion to make the savings account into the scholarship account once a final monetary determination is made, seconded by Karen Collins and carried unanimously. Mary reported on the cost of insurance bonding for the 5 officers. The cost is \$125.00 per year for \$10,000 of coverage. Motion was made by Mitchell Bush to approve \$10,000 in coverage for the 5 officers, seconded by Steve Hill and carried unanimously. Mary is looking for storage for the items left over from the Silent Auction. Mary will continue to store. Keith Hunsucker will look in to what it would cost to post and sell items on the AIS website using the PayPal account. This would not only be AIS items but things members want to sell also. He will also look into paying memberships online. Mary reported that Bonnie Cote had agreed to do arts and crafts at the Thanksgiving dinner. It was reported that AIS is picking up the postage for the newsletter. There was discussion about creating an indicia account for postage. Postage would then cost us \$.28 per newsletter and there is a \$185 yearly fee. Michael Nephew requested \$500 to start to correct AIS's status with Dun & Bradstreet. Dun & Bradstreet had incorrect contact information for AIS and this has made it difficult for us to get credit. Motion made by Mitchell Bush to authorized \$500 to start to correct AIS's status with Dun & Bradstreet, seconded by Darlene Farmer, carried unanimously.

*Old Business*: Elections for the vacant 2<sup>nd</sup> Vice President position were held. Nominations of John Wigle, by Mary Sunbeam and seconded by Manuel Rodriguez and of Steve Hill, by Sam Wakefield and seconded by Mary Sunbeam.
